- □ Hot water heaters
  - SRG will talk to Dan from All Temp Control regarding replacing copper with copper.
  - o Find out how much electricity a new hot water heater will save per year
  - o Find out about energy rebate options
  - Send letter to homeowners with information regarding hot water heaters. Letter will include the following:
    - Electricity savings
    - Rebate information
    - Price-\$689 each, installed-Bradford White 50 gallon heaters
    - Sign up by March 1, 2011-Replace in April
    - HOA will pay for ball valve replacement when water heaters are replaced.
- □ Laundry Room Hot Water Heaters
  - o \$888.79 each
  - o 50 gallon gas Bradford White, 7 year manufacturer/2 year parts and labor warranty
  - o Steve made a motion to replace laundry room water heaters. Linda seconded and with all in favor, the motion passed.

## B. Energy Audit

- O The energy audit was reviewed. The Board agreed to complete the weather-stripping replacement / additions, and complete items related to electrical heat savings.
- SRG presented a bid to replace the Electric Baseboard heaters of \$2250; however, it was not recommended to change out the electric heaters from an energy usage standpoint.

- A. HB 10-1278-SRG has registered the Cedar Lodge HOA, keeping you in compliance with the latest changes in legislative requirements.
- B. Sliding glass doors-Lynda asked for suggestions on failing sliding glass doors. Suggestions were replacing glass, replacing doors themselves, and putting weather stripping on doors.
- C. Hot Tub
  - a. SRG will put up a sign in the hot tub area stating that appropriate attire must be worn and no glass of any kind in hot tub area. Chris will place plastic cups in the kitchenette for guest use.
- D. Letter will be sent to homeowners reminding them of Frisco occupancy code-only 2 guests for every 200 square feet of unit size.
