- **III. Owners Forum** No owners, other than Board members, were present.
- IV. Approval of Minutes The next item of business was the review of the January 18, 2014 Board meeting minutes. Angela made a motion to approve the meeting minutes as written. Colette seconded and with all in favor, the motion carried.
- V. Financial Report Deb reported on the March 2014 close financials as follows:
 - □ March 2014 Balance sheet reports \$3,795.64 in operating, \$52,607.16 in the reserve account and \$3,450.88 in the hot tub account.
 - □ March 2014 P &L states that Cedar Lodge is \$852 over budget year to date in operating expenses.
 - □ SRG and the Board reviewed the major areas of variance.

 - □ March reserve contribution and hot tub reserve contribution was not made due to large snow removal bill and insurance premium. SRG will plan to make the transfers as cash becomes available.
 - □ The 2013 tax return has been filed and nothing is owed.
 - □ All owners are current with dues.

- B. Striping and Numbering Angela made a motion to hire Mountain Striping to stripe and number the exterior parking spaces for a cost of \$250. Colette seconded and the motion carried.
- C. Bird Feeders One unit has several bird feeders on their deck, which is making a mess on the ground below. The Board will take a look next time they are up and will this be discussed that the next board meeting.
- D. Annual Owner Meeting Two changes will be made to the mailer. Roof status will be discussed under the Managing Agents Report. The Board terms of Colette and Angela are up for election this year.
