Owner has not paid his mortgage, so on November 6, 2013, Suntrust has filed their motion for relief of stay. On November 22, 2013, the owner of S6 filed a self-prepared response. Unless the court requires a hearing on the Motion, it is likely that an Order will issue this week. Suntrust will be able to continue their Public Trustee Sale after the stay is lifted.
