- A. Complete / Report Items

A notary will be present at the annual meeting for notarizing the Power of Attorney document for those owners present. For those owners who have not returned their documents, a stamped return envelope will be provided with a mailer to those owners.
- B. Deck Repairs True Exteriors has been informed that the Board has approved them to complete the deck repairs, and that the final approval will be given after August 25, 2018, when the vote will take place at the HOA meeting.
- C. Asphalt This will be tabled until a later meeting.
- D. Concrete Settling at S1/S2 This will be discussed at the meeting in June.
- E. Trees Deb reported that an evergreen tree This will be tabled until a later meeting. Mary will call a nursery and determine a quick growing and hardy tree to plant.
