OWNER'S FORUM

It was noted:

- Swelling is occurring in G48's belly bands. It looks like the painters did not re-caulk the windows appropriately. The owner will send pictures to WPM and the Board will check units.
- WPM will give G48 their markers back.
- Raking can help avoid insecticides.
- Bird's nests cannot be taken down or destroyed once birds have migrated.
- C11 requested a rock be placed between Sapphire Cove and Glen Cove (because a tree was knocked down by a car).
- G79 has trouble with ice dam build ups. WPM will monitor and confirm heat tape is working at garage.
