- The board approved crack sealing the parking with Jet Black for \$1,200. After review of the capital plan, seal coating was also moved up to 2018 instead of 2019. SRG will also get pricing on repairing the asphalt above the drainage culvert.
- SRG will clean or replace the rusted ceiling vents in the pool area.
