I. CALL TO ORDER

III. APPROVE PREVIOUS MEETING MINUTES

The Board reviewed the minutes from the October 25, 2013 Board Meeting. Diane moved to approve the minutes of the October 25, 2013 Board Meeting as presented. Dave seconded and the motion carried.

IV. FINANCIAL REPORT

The Board and SRG reviewed the financials as follows:

January 2014 close financials report \$6,217.65 in the operating account, \$8,095.80 in the Alpine Bank T Bill account, \$96,088.13 in the Reserve account and \$110,517.61 in the Roof Reserve Account.

January 2014 close Profit and Loss statement reports that the association is \$1,717.96 over budget in operating expenses.

Areas of major variance include:

- 508 Repairs and Maintenance is \$2,042 over budget; the overage was due to:
 - o Boiler Inspections \$3,420
 - o Gutter Clean Out and Heat Tape Check \$850
- 545 Irrigation Water \$1,294 under budget

The Board discussed putting the roof reserve money into a CD. SRG will shop rates and contact the Board via email.

The Board reviewed the Capital Plan and discussed the following projects for 2014:

- Phase 2 of exterior building stain for buildings 1512, 1510 and 1508 \$31,000 is in the budget for this phase of staining.
- Asphalt seal coat, crack seal and patching \$9,500 in the budget for asphalt work.
- Swallows \$1,000 in budget for this project

The Board approved the financials as presented.

- D. Dumpster Enclosure The Board discussed placing doors on the front of the dumpster enclosure. Dave asked if there have been many requests from owners. The cost for gate installation is \$6,000. This amount would be split between the townhomes and the Villas. The Board is not 100% in favor of adding the dumpster enclosure doors for initial costs, on-going cost, maintenance and snow removal reasons. SRG will share the Board's opinion with the Villas of Prospect Point Board members at the meeting next week. The Board will go to other complexes to see samples of the dumpster enclosure doors.
- E. Recycling Glass may no longer be comingled with other recycling in accordance with Summit Daily newspaper article. Waste Management is not in favor of taking glass out of comingling. PPT will continue to comingle the glass with recycling until directed otherwise. SRG will keep the Board updated.
