- □ 103 Allegra Pedestal light repair (knocked over)
- □ 110/112 Allegra Heat tape has been repaired
 - □ SRG will call Xcel Energy regarding cost savings to lock electric meters for the summer.

Report Item

- □ Gutter/ diverter install option over garages "short roof"; 42 sections (2 per building)
 - o Sample Diverter installed 116 Allegra, \$50 each –
 - o Sample "connecting" Gutter was installed at 172 Robin for \$125.
 - The gutter install is the preferred fix
 - Shane will get a list of units on which gutter install is necessary.
 - SRG will obtain bids to have the gutters installed, and motion will be done via email
 - Gutter clean-Board decision to have gutters cleaned with power washer by Nevicosi for \$1,600. Will re-evaluate in the fall to see if cleaning is necessary again for any of the gutters.
- □ Paint-Board reviewed paint bids for the entire complex and individual areas of the complex.
 - o South and southwest sides of buildings (dark trim) chipping badly
 - o Doors and trim necessary on all buildings
 - o SRG and Bob will walk the complex next week to determine what painting is necessary for 2012.
 - Peak to Peak and Sunshine will re-bid specific items for presentation to board.
- □ Asphalt-SRG will confirm that Jet Black does not spray for seal coat, but squeegee.
 - Jay made a motion to have Jet Black crack seal, seal coat and restripe complex for \$15,050. Dave seconded and with all in favor, the motion carried.
 - o Advance notice will be sent to owners.
 - o SRG will talk to Jet Black about crack sealing while ground is still cold and cracks are bigger. Would it be better to crack seal now and seal coat later, or would that make asphalt buckle?
- □ Tree Spraying will be done next week by Ascent Tree Services. Will begin root feeding and insecticide within two weeks.
- Landscaping to be done this year by Tate Enterprises. Have started already. Tate will contact Premier about fixing sprinkler heads. Tate will do for \$20 per head and bill Premier.
- □ Drainage at 166 Robin and 110/112 Allegra-Rocks will be moved for better grade.
- □ Website passwords-Board discussed changing password to the Ponds section of the website to prohibit Realtors from accessing the information that is not necessary for them to access. Bob and Deb will come up with a plan and email owners.
