## **UPPER DECK EXTENSION PROPOSAL**

The original article from the Spring Newsletter sent the first of May is as follows:

"For those who attended the annual meeting there was discussion concerning the construction of small decks adjacent to the master bedrooms. Mark and Susan McClurg of 144 Allegra have investigated the feasibility of such an addition to the units and have determined that the costs should run between \$8,000 and \$12,000.

The Board has reviewed this subject and agreed that prior to the expense of architectural and engineering fees to be spent by the McClurgs we should know how many owners would be interested in such an addition.




CONSTRUCTION ZONE!

## **ALERTII DISHWASHERS RECALLED**



On May 16th, General Electric (GE) issued a recall of 2.5 million GE built-in dishwashers manufactured between September 1997 and December 2001. We have just discovered that the dishwashers originally installed in your unit may be on the recall list.

The problem poses a potential fire/safety hazard, and we urge everyone to look into this as quickly as possible. You can go to GE's website at http://www.geappliances.com/products/recall/ for more information. You will need your model and serial number. A rebate is available to go towards purchase of a new dishwasher.
