- B. Landscape Committee Report The Board reviewed the landscape committee report that was provided in the meeting packet. The committee chair and others on the committee will be asked to attend the next Board meeting on April 9. SRG will invite the Landscaping Committee to the next meeting to discuss their plans and answer their questions.
- C. Roads Scott has talked to Robert Jacob, County Engineer, twice and there are no planned improvements scheduled for WPR roads. The county will assess WPR Road and other roads in Summit Cove community this spring. Robert will keep Scott updated so he can report to the community at the annual meeting. Scott will continue to stay in touch with the county regarding their plans. Dave also had a conversation with Robert regarding the inspection for Telluride and the portion of the loop that is on probation. Thad Knoll is the contact for WPR regarding the budget for roads. Scott and Dave are willing to meet with Thad Knoll regarding the roads. Scott will call Dave next week and schedule a time to have a conference call.

VIII. NEW BUSINESS

A. Front Entrance Sign – Innovative Energy will be asked to look at the sign to see why the light is not on every night. They will also be asked if the battery needs periodic maintenance.
